Director's Report

2022 MWPA AGM - September 13, 2022

On behalf of the MWPA Board of Director's, we are submitting a combined Director's report highlighting our activities over the past sport season.

Membership:

435 members as of August 31, 2022

- Short-term goal is to rebound our membership to pre-C19 numbers of 600+ for the 2022-23 season
- Long-term goal membership of 1000+
- Membership fees were reduced during Covid-19 and will remain as is for the 2022-23 sport season
- Advertising campaign with the City of Winnipeg Recreation Services to help support Club recruitment

School League Water Polo:

132 HSL participants

- A modified HSL Program delivered
- Water polo 4s introduced
- Gender specific play introduced

Middle Years school league program cancelled due to Covid-19 restrictions and vaccination rules.

Coach Education:

- Community Coach Workshop offered 11 certified
- Competition Coach Evaluation 1 certified
- Course fees waived and supported by PSO
- New coaching requirements established for 2022-23 with screening policy

Officials Education:

- Regional Referee course offered 20 new referees trained
- Regional Referee evaluations 5
- Course and evaluation fees discounted and supported by PSO

RTP Plan:

Ongoing updates throughout the sport season to MWPA Return to Play Plan in partnership with stakeholders.

Grants:

A total of \$19,000 paid out to supporting Clubs and membership to assist in program and athlete development in Manitoba.

Covid-19 Funding:

CEWS - \$6,251 CERS - \$164 MB Bridge Grant - \$5,000

Pool Space Proposal:

A pool space proposal submitted to City of Winnipeg highlighting ongoing challenges in securing pool space throughout the city.

Sport Programming:

Sport programming delivered in most cases at 50% capacity due to ongoing Covid-19 restrictions and a slow return to play.

Policies:

Ongoing work on PSO policy structure and framework. Approval of several new policies: discipline, appeals, code of conduct

Coaching requirements for 2022-23 updated with screening policy.
